CALL TO ORDER

Chair Modory called the meeting to order at 7:01 p.m. A quorum was present.

Commissioner Alderks requested three items be added; a review of where the City stands with respect to 115th Street, the Annexation Agreement between Dundas and Bridgewater Township, specifically what the letters going back and forth between the two entities are about, and a discussion about adding an on-going item on future agendas titled "Communication." PUBLIC HEARING

<u>Consider an Ordinance Amendment Related to the Review Process for Final Plat Applications</u>
Chair Modory opened the Public Hearing at 7:07 p.m.to consider an Ordinance Amendment Related to Review Process for Final Plat Applications.

Staff Presentation: Currently, the City's Zoning Code requires the Planning Commission to review a final plat application. The only review criteria is that it is consistent with the preliminary plat approval. This review is typically fairly simple and is required to be done by State Statute, within 60 days. Therefore, it may be prudent to not require the Planning Commission to review the final plat. Public Comment: There was no comment from the Public.

OLD BUSINESS

Tower Heights Final Plat

City Planner Sparks stated an application for a final plat known as Tower Heights has been submitted for review and a recommendation to Council. He referred to his memo and reviewed the proposed preliminary plat for 34 single family lots and homes along with five outlots stating a revised landscaping plan was required for the final plat. Sparks indicated the City Engineer will handle the issues of grading, drainage, utilities and an easement hearing is schedule with the Council. He stated the applicant will be required to enter into a development agreement with the City.

Motion by LaCroix, second by Switzer to recommend to Council approval of the Final Plat for Tower Heights as it is generally consistent with the Preliminary Plat, and to enter into a development agreement and all comments have been addressed from the City Engineer and City Attorney. MCU

NEW BUSINESS

Recommendation to City Council on an Ordinance Amendment Related to the Review Process for Final Plat Applications

City Planner Sparks referred to his memo reviewing proposed amendment to modify language from the Subdivision Ordinance. He stated while it used to be common for Planning Commission to review Final plats, it is becoming a lesser practice since generally preliminary plats have become more comprehensive with few matters left to resolve.

Motion by Morlan, second by Swartwood to recommend to Council to consider an ordinance amendment relating to Final Plat review. MCU

WWTF Capacity Issues

Commissioner Morlan again raised his concerns regarding additional flow to the Northfield WWTF because of growth in both Dundas and Northfield.

115th Street

City Engineer John Powell indicated that the City is in the very initial stages of reviewing 115th Street, noting that stakeholder meetings have not yet been scheduled. Alignment options would be an outcome of those meetings.

Annexation Agreement

Commissioner Alderks had asked what the City's position was with respect to the initial letter from Bridgewater Township's attorney. City Attorney Jared Shepherd responded that according to his review and interpretation of the agreement, no annexation is allowed until a Development Agreement is entered into and went on to further clarify that development in one area of the city doesn't not impact the ability for development in another area.
